I, Vidhya Baid, Practising Company Secretary (FCS:- 8882/CP:- 8686) and proprietor of M/s. Vidhya Baid & Co., Company Secretaries, Kolkata was appointed as the Scrutinizer in connection with the Postal Ballot Notice dated 26th February, 2026 of **BENGAL STEEL INDUSTRIES LIMITED** (the "Company") for the purpose of scrutinizing the e-voting and voting through postal ballot forms in a fair and transparent manner and ascertaining the requisite majority for the said voting as per the provisions of Section 108 and 110 of the Companies Act, 2013 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended, on the resolution referred to in this report.

My responsibility as a Scrutinizer is to ensure that the voting process both through e-voting and by use of postal ballot forms are conducted in a fair and transparent manner and render Scrutinizer's Report of the total votes cast "in favour" or "against" if any, on the resolution to the Director/Authorized Personnel, based on the reports generated from the electronic voting system provided by National Securities Depository Limited (NSDL) and of voting through postal ballot forms.

I submit my report as under:

1. The notice dated 26th February, 2026 along with statement setting out material facts under Section 102 of the Companies Act, 2013, as confirmed by the Company were sent to the shareholders of the Company electronically only to those Members, whose names appear in the Register of Members/list of beneficial owners as received from National Securities Depository Limited ('NSDL')/ Central Depository Services (India) Limited ('CDSL') and who have registered their e-mail addresses in respect of their holdings with NSDL/CDSL through the concerned Depository Participants and with Company's Registrar and Share Transfer Agent.
2. The e-voting period and voting through Postal Ballot remained open from Tuesday, 3rd March, 2026 at 9.00 a.m. and ended on Wednesday, 1st April, 2026 at 5.00 p.m.
3. The Shareholders holding shares as on the "cut off" date, i.e. 27th February, 2026 were entitled to vote on the proposed resolution as mentioned in the Postal Ballot Notice dated 26th February, 2026 of the Company.
4. The Postal Ballot form(s) were kept under my safe custody in sealed and tamper proof ballot box before commencing the scrutiny of such postal ballot forms. All postal ballot forms received till 1st April, 2026 upto 5.00 PM, the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.
